## Methods and material for containment and cleaning up:

If battery casing is dismantled, small amounts of electrolyte may leak. Collect all released material in a plastic lined container. Dispose off according to the local law and rules. Avoid leached substances to get into the earth, canalization or waters.

## Section 7- Handling and Storage
