SECTION 4: First aid measures

4.1. Description of first aid measures

General information

First aider: Pay attention to self-protection! Remove affected person from the danger area and lay down.

After inhalation

Provide fresh air. If breathing is irregular or stopped, administer artificial respiration. No mouth-to-mouth or mouth-to-nose resuscitation. Use Ambu bag or ventilator. Call a physician immediately. Move victim to fresh air. Put victim at rest and keep warm. In case of accident or unwellness, seek medical advice immediately (show directions for use or safety data sheet if possible).

After contact with skin

After contact with skin, wash immediately with polyethylene glycol, followed by plenty of water. Take off immediately all contaminated clothing and wash it before reuse. If skin irritation occurs: Get medical advice/attention. After contact with skin, wash immediately with plenty of water and soap.

After contact with eyes

In case of contact with eyes flush immediately with plenty of flowing water for 10 to 15 minutes holding eyelids apart and consult an ophthalmologist. In case of contact with eyes, rinse immediately with plenty of flowing water for 10 to 15 minutes holding eyelids apart. Medical treatment necessary.

After ingestion

Observe risk of aspiration if vomiting occurs. Do NOT induce vomiting. Adverse human health effects and symptoms: Gastric perforation. Call a physician immediately. Do not allow a neutralisation agent to be drunk. Rinse mouth immediately and drink plenty of water. Do not leave affected person unattended. Caution if victim vomits: Risk of aspiration!
